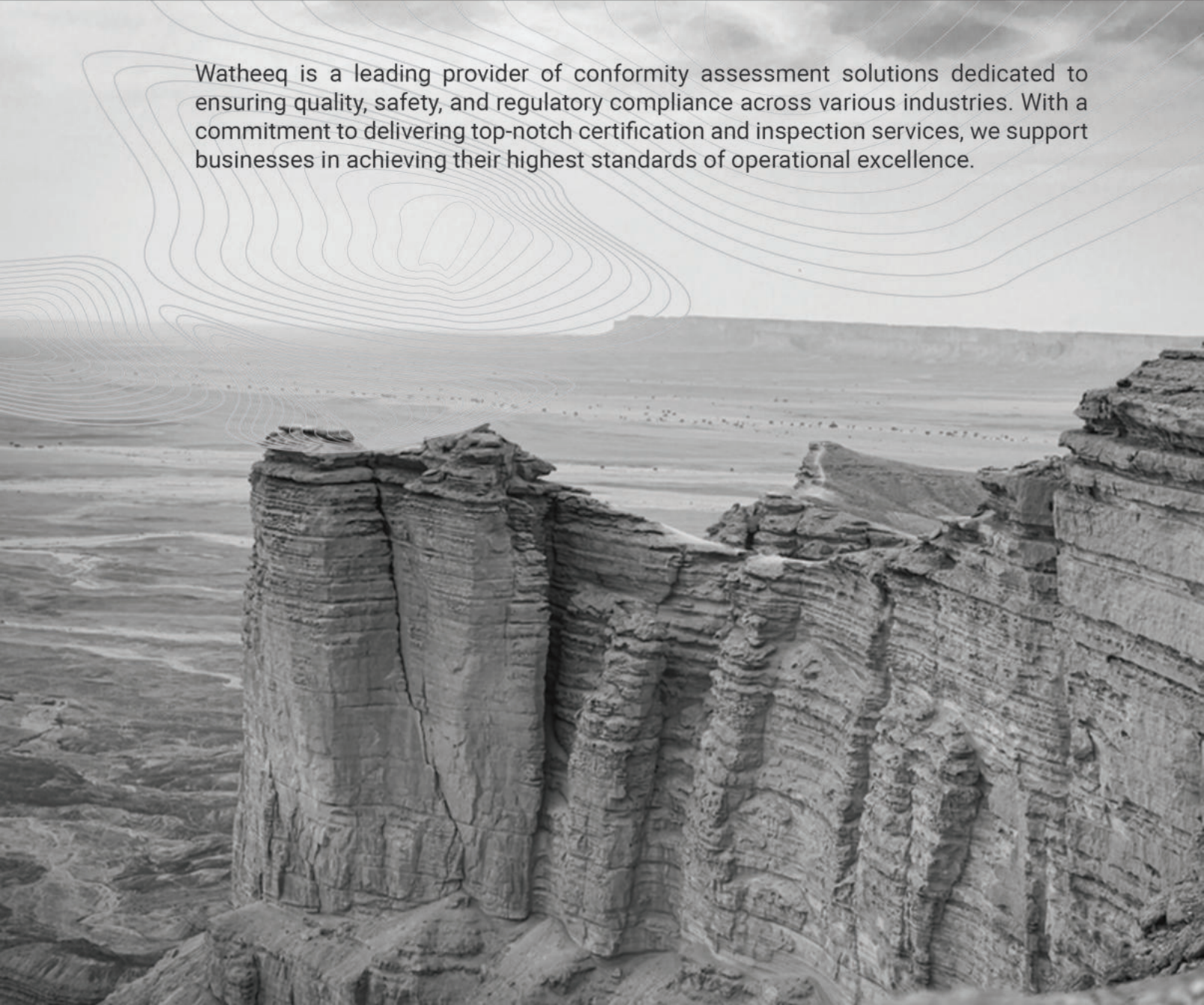

SABER SERVICES



Saber platform is an electronic platform that facilitates the beneficiary's journey in the process of registering products, certificates of conformity, and issuing shipment certificates to ensure their safety before entering the Saudi market.



Product registration in the saber platform and Non regulated Self Declaration :

Watheeq, as an approved Conformity Assessment Body (CAB), offers full support for product registration on the SABER platform. We assist in issuing Certificates of Conformity for regulated products and Self-Declarations for non-regulated products.



Product Certificate of Conformity (PCoC) :

The PCoC is issued per product type after verifying that the product meets the applicable Saudi Technical Regulations. This certificate is valid for one year and is a mandatory step before importing any regulated product.



Shipment Certificate of Conformity (SCoC) :

The SCoC is issued per shipment through SABER after confirming that the products being shipped are identical to those covered by a valid PCoC.

Certificate of Conformity for Low Voltage Equipments (LVE)

Watheeq provides PCOC (Product Certificate of Conformity) and SCOC (Shipment Certificate of Conformity) for LVE (Low Voltage Equipments) to ensure electrical and electronic products comply with safety standards before entering the market. Our accreditation by SASO (Saudi Standards, Metrology, and Quality Organization) and SAAC (Saudi Accreditation Center) guarantees compliance with international regulations, helping businesses achieve seamless market entry.

Gulf Conformity Mark (G-MARK)

The G-Mark, issued under the Gulf Technical Regulation by the Gulf Standardization Organization (GSO), is a mandatory conformity mark for certain regulated products such as toys and low-voltage electrical equipment entering the Kingdom of Saudi Arabia. It indicates that the product complies with essential health, safety, and environmental requirements, and has been assessed by a Notified Body when required.

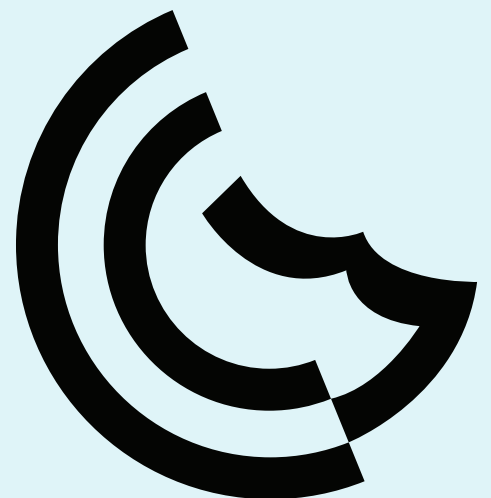
Benefits of Obtaining the G-Mark:

Market Access: Enables legal sale and distribution of regulated products across all GCC countries.

Consumer Trust: Demonstrates product compliance with strict safety and quality standards, increasing consumer confidence.

Regulatory Compliance: Ensures alignment with GSO technical regulations, avoiding customs delays or rejections.

Competitive Advantage: Highlights your product's credibility and commitment to safety, giving you an edge over uncertified competitors.



Saudi Quality Mark (SQM)

The Saudi Quality Mark is a mark owned by the Saudi Standards, Metrology and Quality Organization (SASO) and is granted to products that have been licensed to use it. While it is optional for most products, it is mandatory for specific categories.

The mark indicates that the product has undergone attentive verification and complies with the highest standards, and that the manufacturer operates an effective quality management system ensuring consistent conformity with the general technical regulations related to the Saudi Quality Mark.

Kuwait branch

Kuwait notified the TBT Committee on December 17, 2006, that it intends to implement the new Kuwait Conformity Assurance Scheme (KUCAS) to replace the current International Conformity Certification Program (ICCP).

In consideration of the valuable comments received from TBT Committee members on the KUCAS guidelines, Kuwait hereby informs the TBT Committee that the deadline for comments will be extended and the implementation of KUCAS will be postponed, as indicated in items 9 and 10 of this notification. This will allow sufficient time to study the comments and revise the guidelines as necessary.

The Public Authority for Industry (PAI) in Kuwait issued notification G/TBT/N/KWT/7 on December 21, 2005. Titled the Kuwait Conformity Assurance Scheme (KUCAS), this scheme will replace the current International Conformity Certification Program (ICCP).

Technical Evaluation Report (TER)

The Technical Evaluation Report (TER) is used to confirm that a product complies with the program's requirements and is eligible for export to Kuwait. In simpler terms, the TER represents product registration. Once a product is registered, the exporter can apply for a Technical Inspection Report (TIR) for each shipment to obtain customs clearance.

Technical Inspection Report (TIR)

The TIR, officially known as the Technical Inspection Report, is a mandatory document. For each shipment exported to Kuwait, either the TIR or a Customs Clearance Permit Document must be submitted. Both documents serve as prerequisites for final customs clearance.

If the shipment volume is large and frequent, it is recommended to apply for **TER** first.

TER is the first step to approve your product for export to Kuwait.

The following materials need to be prepared for **TER** application:

- 01 Product test report: The report needs to be issued by a qualified third-party testing agency. If there is already a valid test report, no additional test is required.
- 02 Product pictures and technical parameters
- 03 Fill in the **TER** application form:
If the shipment is not frequent, you can directly apply for a **TIR** certificate before each shipment.



The following materials need to be prepared for **TIR** application:

- 01 Packing List
- 02 Proforma Invoice
- 03 Product test report: It needs to be issued by a qualified third-party testing agency. If there is already a valid test report, no additional test is required.
- 04 CoC application form: The blank application form is provided by the handling agency
- 05 Arrange cargo inspection
